Fortunately, the Alliance has members such as the Mayor Victor Lopez of Orange Cove, who are speaking out. Working hard to educate our elected leaders and the media about the critical importance of San Joaquin River water to communities such as his.

Dear Editor:

As the Mayor of Orange Cove, a small community on the San Joaquin Valley's east side, I have watched my community fight and grow. Our population of 10,000 residents' works very hard. We have six major housing development projects underway and a new high school under construction. A new shopping center along with our middle school and community library were just completed.

Many years ago Friant Dam was constructed along the San Joaquin River to provide reliability to our water supply and meet the needs of our growing population. The jobs in my community come from the agricultural industry supported by water from the River. The source of drinking water in my community is the River. If we loose our water, we will loose everything.

We are one of the major food producing areas in the world, but it seems we don't always get credit for what we produce. People forget where their food comes from – it comes from places like Orange Cove. The idea it isn't a big deal to take our water, is sadly mistaken.

Our jobs and our community are in jeopardy. The California State Legislature needs to recognize there are social, cultural and economic impacts river restoration would have on our community.

Let us not rush to judgment, but work together to build new storage and use our scarce water resources wisely.
